Dear friend,

November is approaching and with it elections, <u>Hunger and</u> <u>Homelessness Awareness week</u>, the second anniversary of the Housing Not Handcuffs Campaign, and the 20th Annual McKinney Vento Awards event.

The affordable housing crisis—and resulting homelessness—are emerging as critical issues in public discourse and we welcome this attention after decades of neglect. After many years of advocacy,

our message that that housing is a human right is beginning to enter the policy mainstream.

It's long overdue. As the crisis deepens, unsheltered homelessness is on the rise and <u>encampments are growing explosively across the country</u>. Despite a growing body of evidence that <u>housing is more effective and cost effective</u>, criminalizing homelessness remains the dominant response in many communities.

But there are also signs of change. The Housing Not Handcuffs Campaign is winning in the courts, in city councils, and in policy debates. Our recent victory in in *Martin v. Boise* is affecting laws and policies in cities across the west. <u>Our panhandling campaign</u> is knocking down bans on asking for help in scores of cities. Campaign members have won victories in <u>places ranging from Lincoln City</u>, <u>OR to Hollywood</u>, <u>FL</u>. More city and <u>law</u> <u>enforcement officials are signing on to our campaign</u> and speaking out to support its message.

The private sector is starting to step up. At this year's <u>McKinney-Vento Awards event</u>, we will honor Kaiser Permanente for it commitment of \$200 million to fund housing and services for homeless people in communities across the country. We will also honor the Goldman Sachs Pro Bono Committee for its pro bono work with us, including surveying homeless New Yorkers on their experiences with criminalization, amplifying their voices.

Government is essential to ending and preventing homelessness, and we are thrilled to also honor Congressman Elijah Cummings for his longstanding support and in particular his work to defend and support Title V of the McKinney-Vento Homeless Assistance Act.

And our new <u>DC Homeless Youth Handbook</u>, developed with pro bono support from Baker McKenzie and Disney, is just hitting the streets!

Ending and preventing homelessness takes the engagement and commitment of all of us. Please join us by <u>endorsing the campaign</u> and <u>supporting the McKinney-Vento</u> <u>Awards</u>.

DC Fare Evasion

Advocates in Washington, DC are pushing a bill to decriminalize fare evasion in the District. As it stands, evading fare on public transit in the District can land you in jail with massive fines. In surrounding states like Virginia, the punishment is a ticket. The bill would lower the punishment for fare evasion to a fine, not an arrest-able offense. <u>Read</u> what advocates are saying on Twitter. 
Update on Boise

The 9th Circuit Court decision in *Martin v. Boise* continues to make waves across the west. The ruling stated that "as long as there is no option of sleeping indoors, the government cannot criminalize indigent, homeless people for sleeping outdoors, on public property, on the false premise that they had a choice in the matter." We have already seen policy reforms in response in <u>Berkeley, CA, Modesto, CA, Sacramento, CA, San Francisco, CA, Portland, OR, Roseburg, OR, Moses Lake, WA, and Olympia, WA.</u> Law Center Senior Attorney Eric Tars provides insight on what advocates should do to inform cities of constructive solutions available in this blog. Imagine a Day Without Water Recap

On October 10th, the Housing Not Handcuffs Campaign (HNH Campaign) participated in *Imagine a Day Without Water*, a national education campaign to engage stakeholders, public officials, and the general public about how water is essential, invaluable, and needs investment. The HNH Campaign took this opportunity to draw attention to the connection between lack of access to water and the criminalization of homelessness.

Many people who are experiencing homelessness lack access to clean water for drinking and basic hygiene. Local policies that criminalize people who need to take care of their biological needs by restricting access to public restrooms and water fountains can result in medical emergencies and unwanted interaction with law enforcement. Several organizations and individuals took part in the campaign by sharing informational images and tweets using the hashtags #ValueWater and #HousingNotHandcuffs. We were able to engage many people on an issue that most do not often think about and appeal to members of fields that are usually not directly involved in issues of homelessness.



Panhandling Campaign

Less than two months ago, the Law Center along with 18 partners in 12 states launched a nationwide effort to strike down bans on panhandling as part of the Housing Not Handcuffs Campaign. The 2015 Supreme Court decision in Reed v. Gilbert held that if an ordinance regulates speech differently based on its content—like whether it asks for a donation versus asking for directions—it is subject to the strictest level of review, and is unlikely to be found constitutional. The Law Center and partners sent letters to more than 240 communities with panhandling ordinances similar to the ones that have been found unconstitutional demanding those laws be repealed. Since the campaign launched, 10 cities have repealed their ordinances and 26 cities have committed to review and amend or repeal their ordinances. Ultimately the goal is to make sure that people don't have to ask for donations in the first place.

Housing Not Handcuffs Update

The Housing Not Handcuffs Campaign now has over 750 endorsements! The Campaign's two-year anniversary is coming up on November 15th and we will hold a web convening on the same day to celebrate the progress it has made as well as to look at next steps going forward. Homeless Youth Handbook Release

The Law Center partnered with Baker McKenzie and the Walt Disney Company to launch a new tool for children and youth experiencing homelessness in Washington, DC. <u>The Homeless Youth Handbook – Options for Safety and Stability</u> was released on Tuesday, October 23. It is a legal guide for homeless kids and youth made available on mobile phones, tablets and computers. The handbook will be available by hard copy at a later date.
